Grower Rewards details and requirements:

1. Qualifying product purchases must be invoiced between Sept. 1, 2007 and Aug. 31, 2008.
2. Claim form and invoices must be submitted by Sept. 15, 2008, to Dow AgroSciences at the following address:

3. Payment will be calculated as a percentage of your total invoice purchases of qualifying Mycogen Seeds and Dow AgroSciences products. If the invoiced amount is greater than 5% over the published Mycogen Seeds suggested retail price and/or the suggested Dow AgroSciences quality image price, the lesser will prevail (i.e., Mycogen Seeds suggested retail price plus 5% will be used instead of price per unit on invoice).
4. Rebate payment will only be made on invoices that are used on the grower's controlled (owned or rented) acres.
5. Rebate payment will only be made on the submitted grower invoices and in the actual grower's name. The name on the invoice must match the name on the claim form. Order forms do not qualify for payment.
6. Participants must submit one claim form only for the program. All chemical and seed receipts must be included. Please make a copy of the claim form and receipts for your records.
